Friedrich Albert Kunz, the son of Ernst Heinrich Kunz and Pauline Wilhelmine Bleyl, was born May 24, 1872 in Euba, Germany. On March 26, 1894, in Euba, Germany, he married Hulda Clementine Purfürst. The second of four children born to Ernst Friedrich Purfürst and Augustine Wilhelmine Uhlig, Hulda was born March 28, 1872 in Euba, Germany,

On March 1, 1902 Friedrich and Hulda Kunz sailed from Bremen, Germany aboard the vessel *Rhein* accompanied by their sons Kurt Kunz, George Kunz and Richard Kunz. They arrived at the port of New York City on March 18, 1902 and immigrated to North Dakota where they established a farm near New Salem, Morton County, North Dakota.

On July 7, 1902 Fred submitted his Naturalization Intention papers at the District Court of Morton County, North Dakota. On July 29, 1907 he submitted his Petition for Naturalization, which was granted on November 18, 1907. This naturalization record stated the family came from "Saxony", Germany and had resided in North Dakota since March 30, 1902.

Friedrich Albert Kunz was born May 24, 1872 in Eibenstock, Germany. He died August 25, 1946 in Bismarck, Burleigh County, North Dakota. Hulda Clementine (Purfürst) Kunz was born March 28, 1872 in Euba, Germany. She died June 19, 1941 in Morton County, North Dakota. They had nine children: Kurt Frederick Kunz, George Henry Kunz, Richard A. Kunz, Helen H. Kunz, Hans A. Kunz, Ernest N. Kunz, Max Frederick Kunz and Walter Edwin Kunz. A son Paul died in infancy in Morton County.

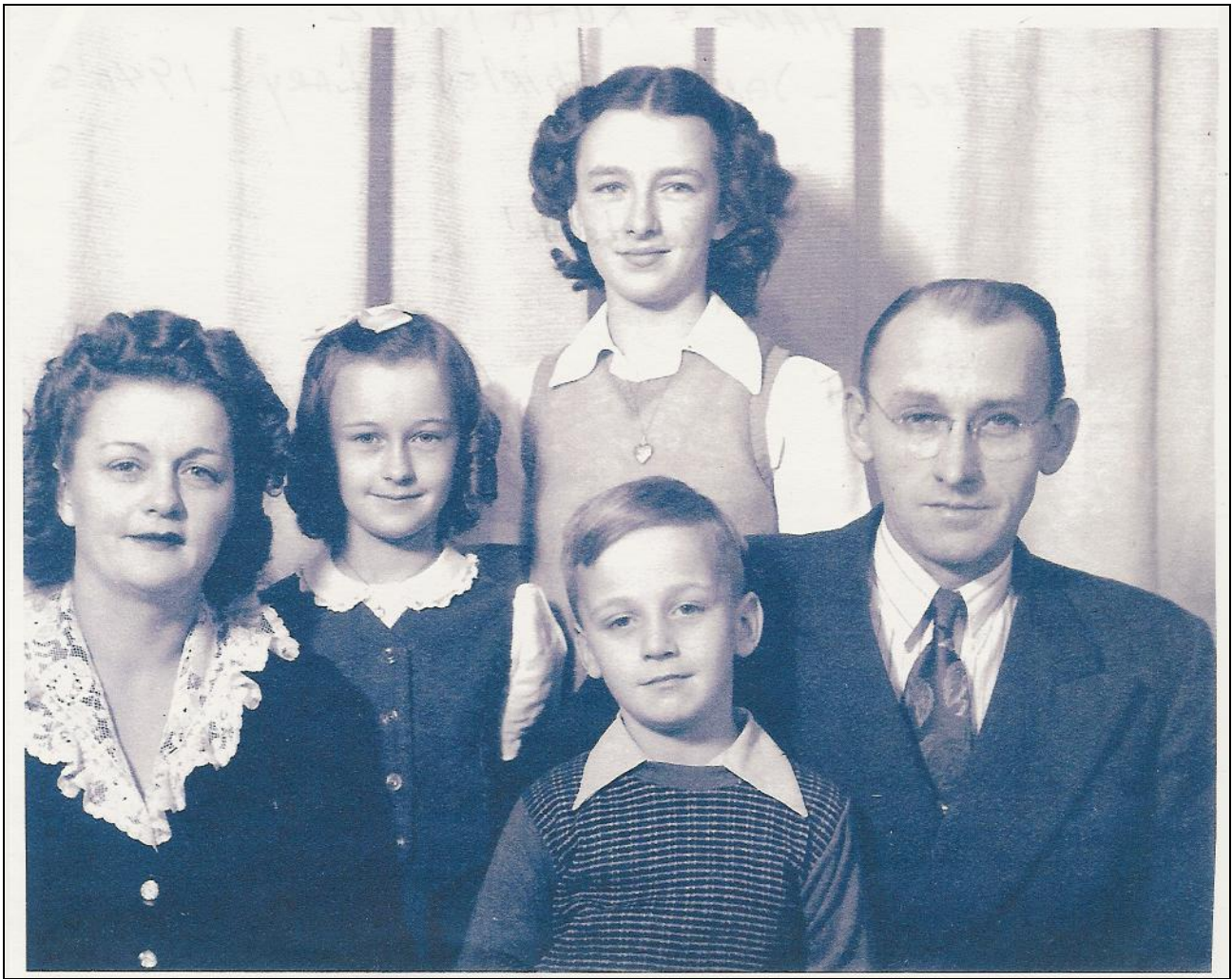
